legislative update

As I prepare this report on legislative activities for the October issue of the Forum, most of us, at least the Northern section of the state, are also dealing with heavy frost each morning - a clear signal that a change in the seasons is soon before us. With about forty days left in Campaign 2012, there continues to be much uncertainty and political pundits are struggling with election predictions. There appears to be about 25 or so legislative races around the State of Minnesota that remain quite close. According to the pollsters, most of the races are considered within one or two percentage points apart. This is significant as a major move to either one of the primary political parties will determine which party will control the 2013-2014 Legislature.

Earlier this summer, there was a prevalent sense we would see a negative reaction to the radical conservative philosophy of "Tea Party" members of the Legislature that could influence elections this Fall. For the most part, that isn't taking place. Most first term extremely conservative legislators appear to be holding their own, and in some cases, even appear to be expanding their base - an example, the primary intra-party contest over the endorsement for the legislative seat held by Rep. Steve Smith. This 13 term legislator was rejected by his own party and lost the endorsement to another Republican because Smith was considered "too moderate". Smith's loss is also a big loss to the Criminal Justice and

Corrections community. Over the years, Legislator Smith consistently advocated for many of our positions. He always expressed his support for the men and women choosing a career in Corrections and was a legislator we could always approach for Republican support. He certainly will be missed.

The effect of Reapportionment earlier this year resulted in several incumbent legislators contending against each other, and also several "open seats" where there are no incumbents. These are very closely contested contests and no real trends are apparent as we near the final month of the campaign. As members of our legislative committee, we urge members to play an active role in the election of your local area Representatives and Senators. *Take the time to meet with them. Inform them of our legislative priorities. Identify the issues in your area.* Electing people who are knowledgeable and supportive of our causes builds greater strength as we work through the Legislative Session.

The MCA Fall Institute is scheduled in Duluth at the DECC, October 24-25, 2012. On October 25th, 10:30 to 11:45 AM, we will present a Legislative Update Session where you will receive a first hand look at the 2013 Legislative Agenda prepared by the MCA Legislative Committee led by Mark Haase, with significant support from the Juvenile Justice Committee. Give us your reaction to that document and submit any other issues or concerns you think we should be considering for the 2013 session. Several legislators will be joining us for an open discussion of legislative issues. As of this report, we have confirmations from Rep. Mary Murphy, DFL from Duluth, and retiring Rep. Steve Smith, Republican from District 33A in the Metro area joining us. We anticipate two or three more legislators to join us, even though our conference is just ten days before the election. Don't forget to express our appreciation to these Legislators who are taking time away from their campaigns to join us at the Fall Institute. It will make for another very popular legislative workshop. See you all at the Fall Institute.

Again, my personal thanks to all MCA's members and the MCA Board of Directors for your continuing support . I truly enjoy representing all of you in our legislative efforts.
