ADULT JUSTICE/LEGISLATIVE COMMITTEE

2023 MCA ANNUAL REPORT FROM THE LEGISLATIVE LIAISON:

As you all are aware, this was a very different legislative year! The MCA Board approved the Legislative Agenda as proposed by the Legislative Committee in December 2022, and I then began the work of getting a copy of the full agenda to Public Safety Committee members of the House and Senate, as well as copies to members of Civil Law and the Division of Children and Families, which was a newly devised Committee put together by the DFL majority leadership. This Committee is chaired by Rep. Dave Pinto, a DFL'er with many years of legislative experience.

As you know, the House Public Safety Committee is chaired by Rep. Kelly Moller, and she was closely assisted by Rep. Sandra Feist, who played a leadership role in introducing new legislation and assisting in moving these bills through the Committee process. The Senate Judiciary and Public Safety Division is again chaired by Senator Ron Latz.

The DFL leadership moved quickly to move things forward and by the end of the second week of the Session, more than 200 bills had been introduced and referred to Committee. The high volume of bill introductions continued throughout the Session and by the time of adjournment on May 22nd, we knew that in all probability a new record of bills had been introduced. Committee hearings moved just a fast with limited time to respond for the most part, and quick action taken by the DFL majority. Republicans assigned to these Committees quickly became frustrated and were vocal about not being able to respond often on proposed legislation. Then fairly early in the Session, our State was hit with terrible weather conditions and at one point more than 30 Committee hearings were cancelled, backlogging the process of moving bills forward.

On February 8th, we conducted our 2023 Corrections Capitol Day event which was totally a Zoom session. We had eight Legislators participate in this event and had an excellent dialogue with Corrections participants. At that point in the Session, there still was this enormous budget surplus exceeding \$ 17 billion, so there was lots of conversation on how that surplus would be used by our elected officials. By early April, when the Legislature took it's Easter break to return to their home areas to deal with constituents, the policy provision endorsed by the DFL were pretty much in place and ready to be incorporated into the Division's Omnibus bills. This too, became very interesting and confusing to most because of it's enormous size. The leadership then also did their own thing by not following legislative rules by adding most of the financial aspects of their proposals into one large bill, so they ended up with a Public Safety Omnibus bill that exceeded 350 pages, which of course was passed and signed by the Governor, and left to all of us to describe what was contained in the legislation.

The result was that we saw more legislation from our legislative agenda become law than we could have ever expected!

Briefly, some of most talked about actions included RESTORE THE VOTE!, Sentence review for Juveniles Certified as Adults to Life Sentences, The Minnesota Rehabilitation and

Reinvestment Act, A supervised Release/Parole Board, a private prison ban, expansion of the Challenge Incarceration Program, emphasis on Mental Health issues and monies for pilot programs, a Family Support unit within the DOC, and much more. There simply was so much for us to be grateful for, but there is still work to be done. A new 2024 MCA Legislative Agenda is now being prepared for presentation at the Fall Institute.

There will be discussion on the MRRA and how can we best address the directives of that legislation, and what is it's impact, work on Offender Reentry, Mental Health and Substance Abuse, The critical need for much needed community based treatment programming and a critical discussion is needed on staffing levels in both institutions and field services, and needed funding for job skill development in the institutions, and much more to come.

So yes, this was a very good legislative year but there is still much work to be done, which will be our objective to assure that Legislators are informed of these needs and why their support is of most importance to us. We will continue to work within the Legislature to see that your concerns are a priority for action. I deeply appreciate the opportunity to work on your behalf and I thank for your support!

Report:

Capitol Day was again held via Zoom on February 8, 2023. We had 92 people attend the session plus guests DOC Commissioner Paul Schnell, Representatives Paul Novtny, Walter Hudson, Sandra Feist, Kelly Moller, Dave Pinto and Jeff Witte and Senators Warren Limmer and Ron Latz attending. It was a great morning of discussions and amount of support expressed by many legislators in support of our work.

The 2023 legislative session could be described as proceeding fast and furious, which left little opportunity for testimonies as many items were put into the Omnibus Judiciary and Public Safety appropriations bill (SR 2909) directly from the committee hearings, resulting in a 529-page bill. Various committee members were involved in some bill aspects and Cal stated busy communicating our interests to the legislators as he was able.

In January the Full Circle Advisory Group work-group recruited people that had served a minimum of five years in prison (state or federal) and have successfully integrated back into the community for at least five years for to be the inaugural group members to be involved in determining focus and parameters of the group. 15 men applied for the group, three did not meet the minimum requirements, 13 were invited for interviews and six completed the interviews and were accepted. Dan Cain and Paul Mikelson have served as the group facilitator and have been meeting twice a month on Zoom since June.

Staffing issues across the corrections system became a topic of discussion. During the months of June, July, and August a small group of legislative committee members (including a few new recruits) met to discuss staffing issues (recruiting, training, retention, working conditions, culture, and morale). Discussion summaries were brought back to the full committee and will be a priority issue for the 2024 legislative session.

The 2024, Annual Training Institute will be held in Mankato, MN. In 2025, the Annual Training Institute will be in Grand View Lodge.

Report:

The Community Supports Committee meets the first Tuesday of the month via zoom. We initially focused on planning for a spring MCA workshop to be held in Willmar Mn this spring and secured a location and developed an agenda for this training. Committee members provided great input and energy into this effort, however, due to the lack of registrations the decision was made to cancel this event. It seems that in the wake of Covid and budgetary restrictions agencies were experiencing holding this event was not feasible at this time.

The Committee continues to meet and has shifted focus to other areas. At present the committee has reached out to DOC staff involved with updates and revisions to policies that impact community organizations that provide supports to persons under supervision or leaving incarceration. The policies are (300.020 Access to Correctional Facilities and Other Department Locations by Non-DOC Persons and 300.040 Volunteer Services Program). These policies impact community-based organizations and their staff and members of the committee would like to provide input to the DOC on any proposed changes to these policies. The committee is also focused on providing input to the DOC with the development of MNRRA policies related to early release from incarceration and community supervision. The community-based organizations want to play a role in rehabilitation and re-investment with the DOC as it moves forward with planning in this effort.

Mission: The Juvenile Justice Committee (JJC) has set out to be a collaborative voice for justice involved juveniles in all delivery systems throughout the state. We strive to promote transformation in the system and focus on being a rejuvenating and positive force within this environment.

Report: On April 20, 2023, the JJC in conjunction with MACPO hosted the 4th Annual Juvenile Justice Conference. This year's conference offered the following presentations:

- MN Juvenile Detention Alternatives Initiative (MN JDAI)
- Olmsted County's Family Violence Response Team
- Washington County's Juvenile Probation Intake Process
- MCF-Red Wing's Programming and Services

In addition to planning and hosting the annual conference, other highlights of 2023 include:

- Collaborated with MCA's legislative committee on juvenile related legislative priorities for 2024.

Report:

MCA Scholarships:

- We continued our two MCA academic scholarship plan in 2023 in the amount of \$500 each. This high school scholarship to be awarded in the Spring of the academic senior year and the college level scholarship to be awarded in Fall/Winter of the academic year.
 - The MCA Scholarship for high school students was awarded to one student in May 2023. Committee membership was actively involved in selection of the 2022 high school scholarship winner. A FORUM article announcing the winner was made in the summer of 2023. A committee member was able to award this scholarship in person at the high school awards ceremony. This was a great step towards additional community engagement for MCA.
